This document contains the core training that will be taking place during 2017/18. Alongside the core training and where possible, there will be team specific children's services training and additional events both for CTSCB and Children's Services, to meet emerging needs:

Application to Attend In-House Training Courses

1. Information regarding the training courses will be sent to Team Managers via email or hard copy.
2. Applications to attend training can be sent via e mail to socialcaretraining@rctcbc.gov.uk or tel. 01443 668874 or enrolled directly via SDMS for those who have access. Team Manager approval must be sought before applying to attend.
3. Approximately 2 weeks prior to the training date you will receive an e-mail from the Training Unit confirming your place on the course.

Please note that places on training courses can be very expensive, we therefore ask participants to inform the training department as soon as possible if they cannot attend. Line managers will be informed if participants fail to attend.

Tea and Coffee will be provided on all courses

Application to Attend External Training Courses

An external application form and course provider's application form must be completed, authorised by the applicant's line manager and sent to the relevant training officer at Heddfan. A decision will be made, based on whether or not the training need can be met in house, and applicant informed accordingly. The course will be booked via Heddfan.

NB. Travel and accommodation expenses will not be met by the training budget.

Mae grant y SCWDP yn bodoli er mwyn cyfrannu tuag at anghenion dysgu a datblygu'r sawl sydd yn y sector gofal cymdeithasol. Felly, ar y sail honno, fydd dim modd iddo fod mewn sefyllfa i gwrdd ag anghenion y sector cyfan.

Byddwn ni'n rhoi blaenoriaeth i'r sawl sy'n gweithio yn y sector gofal cymdeithasol ledled Rhondda Cynon Taf a Merthyr Tudful a gomisiynwyd gan y naill awdurdod lleol, neu gan bartneriaid statudol h.y. ieched; addysg; profiannaeth; yr heddlu, lleoliadau blynyddoedd cynnar. Bydd dosbarthiad yn cael ei rannu mor gyfartal â phosib rhwng pob gwasanaeth. Bydd unrhyw leoedd dros ben yn cael eu dosbarthu i feysydd gwasanaeth sy'n galw amdano - mae enghrheifftiau'n cynnwys y gwasanaethau hamdden, cymdeithas tai, Cymunedau yn Gyntaf, gwpliau cymunedol ehangach.

ON - os bydd cymhwysedd gwasanaeth/asiantaeth o ran blaenoriaeth yn cael ei gwestiynu, yna'r swyddog hyfforddi perthnasol a/neu'r rheolwr datblygu'r gweithlu yn gwneud penderfyniad cyn cadarnhau.

Eligibility

The Cwm Taf Social Care Workforce Development Service is required, through its Social Care Workforce Development grant from Welsh Government, to deliver learning and development plans reflective of agreed prioritised need to the whole of the social care sector in the region of Cwm Taf.

It is also worth noting the following extract from the Welsh Government Circular that governs the administration of the grant

"Since staff members are the principal resource for providers of social care their learning and development needs to be planned, resourced, delivered and evaluated effectively. The primary responsibility for these tasks remains with employers. The SCWDP grant is intended to provide a **significant supplement** to the resources provided by employers to train and develop their own staff."

(Page 2 of the Social Care Workforce Development Programme 2017-18: Circular)

The SCWDP grant is in place to provide a contribution to meeting the learning and development needs of those in the social care sector and on that basis will never be in a position to meet the needs of the whole sector

In an attempt to provide some clarity for providers in terms of accessing learning and development programmes through the Cwm Taf Social Care Workforce Development Service, the following has been agreed:

Eligibility to access safeguarding adults and children learning and development

Priority will be given to those working in the social care sector across RCT and Merthyr that have been commissioned by either local authority and statutory partners i.e. health; education; probation; police; early years settings; with distribution being as equitable as possible to all services. Any spare capacity will be given to any other service requesting access - examples of which could be leisure, housing association, communities first, wider community groups, etc

NB - if there is a question of where a service/agency fits in terms of priority then a decision will be reached by the relevant training officer and/or workforce development manager prior to confirming
